## Accessibility Statement for iPerform

Network Rail is committed to providing a web application that is accessible to the widest possible audience, regardless of technology or ability. We have worked to increase the accessibility and usability of this web application and in doing so follow many of the available standards and guidelines.

We also routinely check this web application when updates are made to ensure that they meet accessibility requirements.

Whilst we work to the accepted guidelines and standards for accessibility and usability, it is not always possible to do so in all areas of the web application. We acknowledge that this is a work in progress and there are improvements that can be made.

### Using this Web Application

We want as many people as possible to be able to use this web application. For example, that means you should be able to:

- Understand presented information without relying on colour

- Change text style properties without breaking the page
- Content is presented in a meaningful order.

#### How accessible this Web Application is

We know some parts of this website are not fully accessible:

- Elements of the web app do not have name tags and therefore cannot be identified by name using a screen reader
- Alt text is not included for all images / icons
- Elements of the web app have not been built for accessibility
- The web app cannot be navigated using a keyboard
- The contrast ratio between some backgrounds and text does not meet AA guidelines of 4.5:1 for normal text, or 3:1 for large text (ratio is 2.3:1)
- The contrast ratio between some backgrounds and non-text elements does not meet AA guidelines of 3:1
- Text cannot be resized to 200 % without loss of content or function
- Webapp cannot be browsed using a 320 pixel wide screen

- 2.1.1 (accessible by keyboard only)
- 2.5.3 (text in buttons or label should be readable by assistant technologies and can be used with Text-to-speech)

- 4.1.2 (build all elements for accessibility)
